About the race: The course starts at **Miller Creek Lavender Farm**, 8453 Miller Creek Loop in Johnson City, Texas, 78636, approximately 8.5 miles north of Blanco, 4 miles south of Johnson City. The course follows Miller Creek Loop for a scenic out-and-back. Handsome male servants will staff the aid stations, serving water and Quench sports drink; 5k runners access the aid station twice, 10k runners access the aid station four times. After the race, enjoy a champagne brunch under a grove of oak trees near the lavender fields, along with music, free massages, shopping for lavender products and more.
